

# 2018 Fillmore County No Spray Request Form

Annually, the Fillmore County Highway Department or their contractor will spray county road ditches for noxious weeds. The spray is applied directly onto the noxious weeds. If you have questions about the chemicals being used, please contact our office for a list that will be used in 2018. Fillmore County will have signs available for purchase and the property owner is responsible to install and maintain the signs in the proper location. Signs shall be placed at the beginning and end of the "No Spray Zone" with the blank side of the sign facing the "No Spray Zone".

Fillmore County plans to spray in the fall of the year which is found to be most effective. The Highway Department will continue to mow the first swath adjacent to the roadway as a safety precaution. Fillmore County does not oppose the haying or mowing of the County road ditch as it is another way to combat noxious weeds.
