3. Consider Windbreak Tree Replacement Policy

Grooters proposed creating a replacement tree policy for those landowners who have put in farmstead windbreaks in the last two years using District cost share funding that have had a large number of trees die. Primarily Norway and White spruce have been affected. He suggested offering trees to these landowners at half the current retail price as a good faith effort to help them get their windbreaks back. Eligibility for replacement would be determined by the SWCD technical staff.

Motioned by Hazel seconded by Gossman to offer replacement windbreak trees at half the current retail price after determination by the SWCD technical staff to be dead. Affirmative: Leutink, Mensink, Willford, Hazel, Gossman. Opposed: none. Motion carried.

4. Consider investment of FSP Phase II Implementation Grant funds in the amount of \$400,000.00 at Rushford State Bank at .81% (Money Market)
