1. Supervisor's activity reports

a. MASWCD Area 7 recognition of retiring Supervisors

Retiring supervisors were recognized at the Area 7 meeting. Rasmussen presented a framed certificate to Leutink. Mensink wasn't present to receive hers.

Willford reported attending a Personnel Committee meeting.

Leutink had nothing to report.

Gossman reported attending the 1W1P Public Hearing in Stewartville. He is on the advisory board for Beginning Farmers and Ranchers and attended a meeting in Pennsylvania where they discussed modification of farm programs for 2017-2018.

2. Staff reports

A written report was included in the board packets.

3. Administrator's report

a. Root River 1W1P update

The policy committee reviewed the comments and responses from the state agencies and public hearings and gave approval for the plan to be submitted to BWSR for review.

b. Plat Books

Rasmussen reported the new plat books have arrived. Ten copies were taken to the Recorder's office for sale there.

c. WCA shared position update

A decision regarding the WCA shared position is being delayed by Winona and Wabasha Counties. Winona doesn't want to make a decision until after January 1st. Wabasha is taking back the WCA duties from their county and is not interested in sharing a position. Rasmussen has been talking with Mower County to see if they are interested in sharing the position as most of the wetland work is in the western part of the County.

d. Regional discussion about organizational collaboration

A group of area managers met with representatives from RC&D, the Water Resources board, the Joint Powers board, and BWSR to discuss ways to share funding. These organizations are either lacking adequate funding or growing out of their original role. A presentation is planned for November at the Water Resources Board meeting informing Commissioners what SWCDs are doing.

e. MDA Targeted Township Testing Program

A draft work plan has been sent by MDA to test the private wells in each township in Fillmore County. The proposal is for \$70,000.00 with \$20,000.00 for staff time. Components of the program include developing a mailing list,

outreach and education and coordination with the Olmsted County lab for testing.

f. Flood damage reporting to BWSR

BWSR wants information from SWCD districts in 23 counties listing flood damage to existing and new practices and cost estimates to repair the damage by October 19th.

4. NRCS

Bronson reported FY17 has started. She stated a huge amount of conservation was completed in FY16. NRCS is operating under a continuing resolution. There is a new CSP program starting. Staff will be attending Tool Kit Training. Fall construction is underway. There will be a continuous CRP signup on a first come, first service basis.

5. County

No County representative was present.

The recommendation of the Personnel Committee was to stay with the two tier costs and keep the HSA contribution the same as last year - \$1,500.00 for single coverage and \$3,000 for family coverage.

Either at the Annual Planning Meeting or another specially called meeting after the newly elected supervisors are on board, it was suggested that a more in-depth discussion be held on the insurance plans being offered and the costs to the employees. At that time, the three tier insurance costs will be looked at again. Motioned by Leutink seconded by Gossman to approve a District contribution to each employee with a HSA compatible insurance plan in the amount of \$1,500.00 for single coverage and \$3,000.00 for family coverage.
