- ~~GIS Update – Kevin Stark, St. Mary’s University:~~
- **WCPI Update – Dan Wermager, Root River SWCD:**
  - Required to do 2 outreach events per year, but due to COVID-19, have been unable to have any as of yet. Looking into a virtual field day.
  - Outreach letters have all been sent, all follow-up phone calls have been completed. One walk-over is lined up for Fillmore County, landowner wants to wait until after deer season to complete walk-over.
  - 126 plans completed this year, goal was 100. Two of three internal strategy meetings completed.
  - Looking to focus on Riceford Creek watershed for 2021, compiling contact info over the winter and send out letters in late winter, begin calling people in early spring.
- **RCPP Update – Adam Bielke, BWSR:**
  - State office sign-up numbers have been finalized, Root River Watershed has ~\$50,000 in funds to spend for upcoming year, still looking into getting unused funding from other watersheds.
  - November 20<sup>th</sup>, 2020 is application cutoff for Fiscal Year 2021 RCPP funding requests. Ranking will likely take place in March, 2021.
- **Draft 18/19 Watershed Based Implementation Fund Workplan Revisions:**
  - 2018-2019 Financials
    - 31% of the grant funds are left
  - 2020-2021 Financials
    - Just starting into using funding

  - Winona County has a new contract written for St. Mary’s University Geospatial Services.
  - Emily Zanon – MPCA Updates, Assessment Status for Root River:
    - MPCA has finished determining list of newly impaired waters, and which impaired waters will get TMDLs or not.
    - Nine waterbodies will get new TMDLs, most are TSS, one E.coli, a few for nitrates.
      - Seven waterbodies will get nitrate TMDLs that were already approved in Cycle 1 WRAPS.
    - Next step: writing Monitoring & Assessment Report – MPCA is changing how they write these reports.
      - “What information is most important to you, that we should include in this report?”
