 - Update given by Dan Wermager with Root River SWCD.
- iii. Root River RCPP Update
 - Adam Beilke with BWSR:
 - In April of 2019 this area received its first round of RCPP funding; in the Root River that worked to complete 12 projects – 9 in Fillmore County, 2 in Winona County, and 1 in Houston County.
 - The intention of the funding is to match the state 1W1P dollars used on a project.
 - April of 2020 is the second sign-up timeline; Root River was allocated \$500,000, and there is potential for more to be available if other watersheds do not use all of their allocated RCPP funding.
- → Discussion within the old business topic, the Policy Committee discussed wanting more updates on projects and funding as funding gets moved from one entity to another to complete projects.
- → Quarterly PC meetings also discussed; BWSR stated there is no requirement from the state to have quarterly meetings, and that a meeting schedule is entirely based upon the PC's wants & needs.
